Students who attend Lake Park High School District No. 108 ("District 108") schools receive an excellent education and comprehensive support services to meet their needs. The cost of providing these services is high, and most of the financial burden to fund the schools is placed on residents of District 108 through property taxes. Only residents of District 108, i.e., those who physically occupy and live within a residence in District 108 boundaries, are eligible for enrollment on a tuition-free basis. Mere ownership of a residence within the boundaries of District 108 does not constitute legal residency. Non-resident students who are unlawfully enrolled in our schools put an additional burden on District 108 taxpayers.
