AFFIDAVIT OF RESIDENCY  
RESIDENT HOMEOWNER/GUARANTOR AGREEMENT  
(to be completed if living with a friend or relative)

Students who attend Lake Park High School District No. 108 (“District 108”) schools receive an excellent education and comprehensive support services to meet their needs. The cost of providing these services is high, and most of the financial burden to fund the schools is placed on residents of District 108 through property taxes. Only residents of District 108, i.e., those who physically occupy and live within a residence in District 108 boundaries, are eligible for enrollment on a tuition-free basis. Mere ownership of a residence within the boundaries of District 108 does not constitute legal residency. Non-resident students who are unlawfully enrolled in our schools put an additional burden on District 108 taxpayers.

**REQUIRED PROOFS OF RESIDENCY (for Resident Homeowner/Guarantor):** Proof of residency must be established by uploading documents from each of the following categories to the online registration site along with a copy of this notarized affidavit.

**Category I – (One document required)**

- Current tax bill showing address of residence (homeowners)
- Closing statement documenting the purchase of the address of residence (homeowners)
- Signed lease or rental contract showing the address of residence (renters)

**Category II – (Three documents required which have the correct, current address of residence)**

- Current utility bill(s)
- Voter registration card
- Home or apartment certificate of insurance
- Automobile registration
- Driver's license
- Public Aid verification
- Medicaid medical card

Note: Some of Category II proofs of residency may also be required from the student's parent/guardian.

***For both the Parent/Guardian and the Homeowner/Guarantor:***

**Our signatures below indicate our understanding that only residents of District 108, i.e. those who physically occupy and live within a residence in District 108's boundaries, are eligible to attend District 108 schools on a tuition-free basis. We further understand that it is our joint obligation to promptly notify District 108 of any change in residence. We acknowledge that any person who enrolls or attempts to enroll in the schools of a school district, on a tuition-free basis, a pupil known by that person to be a nonresident of the District, or any person who presents to any school district any false information regarding the residency of a pupil for the purpose of enabling that pupil to attend any school in that district without the payment of a nonresident tuition charge, shall be guilty of a Class C misdemeanor. We understand that if District 108 determines that we have provided false information about the student's residency within District 108, we may be referred for criminal prosecution.**
