

# BOARD BRIEFS

October 23, 2017

## Presentation

Assistant Superintendent for Curriculum and Instruction Jim Roberts provided a brief update about student achievement. He highlighted [student performance from the 2016-17 school year](#) on a number of measures of college and career readiness including SAT performance, Advanced Placement (AP) performance and participation rates, percent of freshmen on track, graduation rate, and CTE/AP/Dual enrollment. Mr. Roberts indicated the 2017 Illinois School Report Card will be released on October 31.

## Discussion Item

Board of Education President Barb Layer led a preliminary discussion about formulating a Superintendent Succession Plan for 2020. Board members acknowledged the difficult decision making process that lies ahead, but want to be prepared by developing a timeline and involving important stakeholders. President Layer and Board member Tom Hollatz will co-chair a sub-committee comprised of Board members Claire Adachi and Keri DeWaele. Future discussion about this process will occur during open session.

## Action Items

### IASB / IASA / IASBO Joint Annual Conference 2017

Pursuant to recent legislation that requires Board member expenses to be discussed in open session, the Board approved conference registration fees for President Layer and Board members Adachi, DeWaele and Janice Gatbunton to attend the Tri-Conference in November 2017.

### 2017 Tax Year Levy

Assistant Superintendent for Business Services Jeff O'Connell reviewed levy projections and presented a resolution regarding estimated amounts necessary to be levied for the year 2017. The 2017 levy revenue is matched against expenditures for fiscal year 2018-19, and that budget is now in a developmental stage. Lake Park's estimated aggregate levy for the year 2017 of \$44,127,300 was approved. This amount does not exceed 105% of the taxes extended on the 2016 aggregate levy. The District anticipates receiving approximately 2.48 percent in new revenue, or roughly \$1,043,280 new dollars, for Fiscal Year 2018-19.

## Superintendent's Report

- Congratulations to Board Member Bob Marino and Assistant Principal Dominic Manola who will be honored by Giving DuPage for their volunteer work with the Flags for Roselle Program. - On November 1, administrators and teachers from Lincoln Way High School District 210 will be conducting a site visit to learn more about Lake Park's 1:1 technology initiative. This opportunity will include classroom visits and Q&A with a panel of teachers.
- The student led Veterans Service Organization is sponsoring a needs drive this week to collect supplies as stocking stuffers for the troops. VSO will donate the contributions to Operation Support Our Troops-America.
- Come out and enjoy the 5th Annual "Best Pizza in Lancerland" to benefit the choral program on November 2 (6-8 p.m.).
