# **Action Items**

### **New Course Proposal** —

### Algebra 3: Transition Math for College

For the 2018-19 school year, the Board of Education approved this year-long course, which is designed for students who have met their high school graduation requirements for mathematics. Students who successfully complete this course may be placed directly into one of five credit-bearing mathematics classes at the College of DuPage. This course emphasizes collaborative, project-based exploration of real world problems to develop mastery of mathematical concepts and skills. An online math platform called *ALEKS PPL* will be utilized throughout the course for remediation, adaptive learning and assessment.

### Board Policy 7.290 —

### **Suicide and Depression Awareness and Prevention**

Earlier this school year, the Board Policy Manual was reviewed by District attorneys. Board of Education members approved legal counsel's recommendation of Board Policy 7.290 Suicide and Depression Awareness and Prevention to be included in Section 7: Students.

# Resolution Approving Workplace Harassment Policy and Uniform Grievance Procedure

Legal counsel reviewed the District's existing Board Policies, which were approved earlier this year, for compliance with Public Act 100-554. Based on the review and legal recommendation, the Board members adopted revised versions of Board Policies 5.20-Workplace Harassment Prohibited and 2.260-Uniform Grievance Procedure to comply with this new legislation. Legal Counsel also advised adoption of a Resolution approving Workplace Harassment Policy and Uniform Grievance Procedure

## Superintendent's Report

Dr. Lynn Panega highlighted recent student recognition and previewed upcoming events.

- On Friday, January 26, staff will engage in a wide variety of learning opportunities during Institute Day. Lake Park faculty members will facilitate instructional technology breakout sessions, while outside experts will present breakout sessions on ESL Instructional Strategies and the resources available through Khan Academy. Teachers from surrounding school districts will participate in some of the workshops as well.
- Several superintendents from area districts and legislative groups including LEND, SCOPE, and Ed-RED are continuing their efforts to strengthen and expand dual credit partnerships between Illinois high schools and colleges. As a next step, a presentation will be made to the Illinois Board of Higher Education, the Illinois Community College Board, and the Illinois State Board of Education in Springfield on Monday, February 5.
- Lake Park East Campus will host a traditional tea on Thursday, February 1, at 3:00 p.m. to empower youth and inspire them to achieve their fullest potential. Motivational guest speakers include Lake Park science teacher Kara Roll and senior student Emily Frank.
