# **Discussion Items**

#### 2020-2021 Academic Calendar

Assistant Superintendent for Educational Services Michael Wojtowicz presented a draft of the 2020-2021 academic calendar with a start date of August 12, 2020 and end date of May 25, 2021. The proposed calendar will be presented for approval in March.

## 2019-2020 Student Registration Fees

For the 2019-2020 school year, the Administration recommended freezing student fees, which are typically aligned to the December Consumer Price Index (CPI) of 2.1 percent. No action is required since the Board supports the freeze for next school year.

#### Post-Issuance Tax Compliance Report

Assistant Superintendent for Business Services Dr. Jeff O'Connell presented information pertaining to the Post-Issuance Tax Compliance Report, which states the District is in compliance with applicable tax law requirements relating to its tax exempt bonds.

#### Superintendent Search

Following presentations from three executive search firms between November 2018 and February 2019, Board members have agreed to initiate contractual services with School Exec Connect to conduct a Superintendent Search for replacement effective June 30, 2020. The Board of Education selected this company for their long history of working with high school districts and a shared philosophy to involve stakeholders in this important process.
